#### **AGENDA**

- 1. Welcome and Call Meeting to Order by Mayor Rivera at 6:02. He stated we do have a quorum and as always God bless our troops where ever they are, especially those in harms' way, also our first responders, police, and fire.

Motion made to approve consent agenda by Councilman Griffin and accepted by Councilwoman Martin. Motion passed unanimously.

#### 9. NEW BUSINESS:

A. Splash Park Naming

Manager Hinton stated that he was asked by Councilman Innes to put this item on the agenda. He requested to read a statement written by family regarding his father and why he thought the splash park should be named after Larry Innes. Councilwoman Martin stated that she didn't like the

thought of naming places after council people. Mayor Rivera stated that he served with Larry for several years and admired him, but we need to make some guidelines as to how we should name things because there are so many politicians, staff, police, and fire fighters and personnel that have been influential. Councilman Griffin stated that we need to look at precedence. Councilman Innes made the motion to name the splash park after Larry Innes, The Larry Innes Splash Park and was seconded by Mayor Rivera. Councilman Rapier made a motion to amend the motion that following this vote that we no longer name anything until a set of criteria is put in place. It was agreed to by Councilman Innes and Mayor Rivera. The vote was 3 ayes by Mayor Rivera, Councilman Innes, and Councilman Rapier, and 3 nays by Councilwoman Martin, Councilman Griffin, and Vice Mayor Allen. The motion died.

Mr. Hinton stated that he would like for Matt, Michelle, & myself to join Council in executive session. Motion was made at 6:58 to go into executive session by Councilman Innes and seconded by Vice Mayor Allen. Motion passed unanimously. Motion made by Councilman Rapier and seconded by Vice Mayor Council to return to regular session at 7:36. Motion passed unanimously

#### 11. INFORMATIONAL ITEMS:

A. Town Manager's Report:

Mr. Hinton stated that we have been working on the parking lot over by the skate park which should add 44 parking spaces up on top and about 50 on the bottom. Eventually that will translate into some parking for the lake if we get to that point. We are still doing some rough calculations on that. Mayor Rivera asked about the parking on the west side of the ball fields, if it is going to continue on to 8<sup>th</sup> Ave. Mr. Hinton said that they are going to pave the road over on that side which will continue all the way to 8<sup>th</sup> Ave. The additional parking will be done before the baseball season starts. Councilman Rapier asked about the time frame on the soccer fields and the town lake. Mr. Hinton answered that the fields will be put into the cue, however the lake is a ways out. Mayor Rivera asked if the soccer fields will be first phase and Mr. Hinton answered yes. At some point in time we will take a few weeks to put in a box culvert at Quail Ridge. Councilman Griffin asked about the park at Quail Ridge. Mr. Hinton stated that he has taken the plans to John Martin and he is in favor of it, but it is on hold until he can get rid of the trailer with all his records that is located where we want to put the park. Mr. Hinton showed a picture of the latest drawing of the roundabout. We are going to put in a walking path down Hoopes that will meet the one that heads down Golf Course Road.

# B. Fire Department Report.

Chief Payne stated that we have been at Light up the Night, and helped Pima with a fire, and were at the Home Depot safety fair. We also helped Pima with a fire at the gin. We are meeting with the fire district next month and hopefully we will have prices for fire trucks.

# C. Police Department

Chief Woods said we received our grants from Stonegarden and that includes the money to purchase a new vehicle to use for that purpose. Brian Brugeman just graduated from the academy and will be our reserve officer. I recently spoke with the Chief from Sierra Vista, they have implemented an adopt a school program where the officer working day shift visits one school every day. Two weeks ago we started having one of our officers' do that which has already made a positive impact on the schools. Rather than try to get funding for a resource officer, we are going to try this and see how it goes. With all the negativity of officers' nationwide right now, this is a very positive experience for our officers to have that interaction.

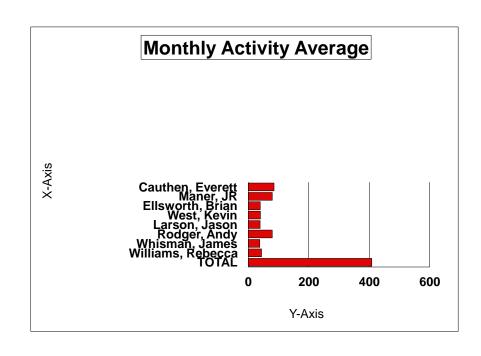

# **RESOLUTION 650-2016**

A RESOLUTION OF THE MAYOR AND TOWN COUNCIL OF THE TOWN OF THATCHER, ARIZONA, PRESCRIBING STANDARDS OF FINANCIAL DISCLOSURE FOR LOCAL ELECTED OFFICIALS.

**WHEREAS**, pursuant to the provisions of A.R.S. § 38-545, as amended, the Town of Thatcher is required to adopt standards of financial disclosure consistent with the provisions of Title 38, Chapter 3.1, Article 1, Arizona Revised Statutes, as amended; and

**WHEREAS**, the Town of Thatcher Council has determined that the standards of financial disclosure hereinafter adopted are, with respect to the Town of Thatcher, consistent with such standards of financial disclosure within the meaning of A.R.S § 38-545.

**NOW, THEREFORE, BE IT RESOLVED** BY THE TOWN OF THATCHER COUNCIL OF THE TOWN OF THATCHER OF ARIZONA, GRAHAM COUNTY, ARIZONA, that the following standards of financial disclosure for local elected officials are hereby adopted:

**Section 1.** DEFINITIONS. In this resolution, unless the context otherwise requires:

- 1. "Business" includes any enterprise, organization, trade, occupation or profession, whether or not operated as a legal entity or for profit, including any business trust, corporation, partnership, joint venture or sole proprietorship.
- 2. "Compensation" means anything of value of advantage, present or prospective, including the forgiveness of debt.
- 3. "Controlled business" means any business in which the local public officer or any member of his household has an ownership or beneficial interest, individually or combined, amounting to more than a fifty percent interest.
- 4. "Dependent business" means any business in which the local public officer or any member of his household has an ownership or beneficial interest, individually or combined, amounting to more than a TEN PERCENT INTEREST, AND DURING THE PRECEDING CALENDAR YEAR THE BUSINESS RECEIVED FROM A SINGLE SOURCE MORE THAN TEN THOUSAND DOLLARS AND MORE THAN FIFTY PERCENT OF ITS GROSS INCOME.
- "Gift" includes any gratuity, special discount, favor, hospitality, service, economic opportunity, loan or other benefit received without equivalent consideration and not provided to members of the public at large. "GIFT" DOES NOT INCLUDE TRAVEL-RELATED EXPENSES THAT ARE PUBLICLY REPORTED AS REQUIRED BY LAW OR POLITICAL CAMPAIGN CONTRIBUTIONS THAT ARE PUBLICLY REPORTED PURSUANT TO TITLE 16, CHAPTER 6.
- 6. "Local public officer" means a person holding an elective office of the Town of Thatcher.

- 7. "Member of household" means a local public officer's spouse and any minor child of whom the local public officer has legal custody.
- 8. "TRAVEL-RELATED EXPENSES" MEANS ANY COSTS ASSOCIATED WITH TRANSPORTATION, FOOD, LODGING AND REGISTRATION FEES AND OTHER EXPENSES DIRECTLY RELATED TO TRAVEL TO, OR FROM, A MEETING, CONFERENCE OR OTHER EVENT WHERE THE LOCAL PUBLIC OFFICER IS PARTICIPATING IN THE LOCAL PUBLIC OFFICER'S OFFICIAL CAPACITY.

**Section 2.** DUTY TO FILE FINANCIAL DISCLOSURE STATEMENT; CONTENTS; EXCEPTIONS.

- A. In addition to other statements and reports required by law, every local public officer, as a matter of public record, shall file with the Town of Thatcher Clerk on a form prescribed by the Town of Thatcher Clerk a verified financial disclosure statement covering the preceding calendar year ending December 31. The statement shall disclose:
  - 1. The name and HOME OR WORK address of the local public officer, WHETHER THE LOCAL PUBLIC OFFICER'S SPOUSE IS A MEMBER OF THE LOCAL PUBLIC OFFICER'S HOUSEHOLD, THE NUMBER OF MINOR CHILDREN WHO ARE MEMBERS OF THE LOCAL PUBLIC OFFICER'S HOUSEHOLD AND ALL NAMES AND ADDRESSES UNDER WHICH EACH DOES BUSINESS. IF DISCLOSURE OF THE IDENTITY OF THE LOCAL PUBLIC OFFICER'S SPOUSE OR MINOR CHILDREN OTHERWISE BE REQUIRED, A LOCAL PUBLIC OFFICER MAY COMPLY WITH THE IDENTIFICATION REQUIREMENT BY USING THE TERM "SPOUSE" OR "MINOR CHILD," AS APPLICABLE.
  - 2. The name and address of each employer and of each other source of compensation other than gifts amounting to more than one thousand dollars received during the preceding calendar year by the local public officer and members of his household in their own names, or by any other person for the use or benefit of the local public officer or members of his household, a description of the services for which the compensation was received and the nature of the employer's business. This paragraph shall not be construed to require the disclosure of individual items of compensation that constituted a portion of the gross income of the business from which the local public officer or members of his household derived compensation.
  - 3. For a controlled business, a description of the goods or services provided by the business, and if any single source of compensation to the business during the preceding calendar year amounts to more than ten thousand dollars and is more than twenty-five percent of the gross income of the business, the disclosure shall also include a description of the goods or services provided to the source of compensation. For a dependent business the statement shall disclose a description of the goods or services provided by the business and a description of the goods or services provided to the source of compensation from which the dependent business derived the amount of gross income described in Section 1, paragraph 4. If the source of compensation for a controlled or dependent business is a business, the statement shall disclose a description of the business activities engaged in by the source of compensation.

- 4. The names and addresses of all businesses and trusts in which the local public officer of members of his household, or any other person for the use or benefit of the local public officer or members of his household, had an ownership or beneficial interest of over one thousand dollars at any time during the preceding calendar year, and the name and addresses of all businesses and trusts in which the local public officer or any member of his household held any office or had a fiduciary relationship at any time during the preceding calendar year, together with the amount or value of the interest and a description of the interest, office or relationship.
- 5. All real property interests and real property improvements, including specific location and approximate size, located in the Town of Thatcher, in which the local public officer, any member of his household or a controlled or dependent business held legal title or a beneficial interest at any time during the preceding calendar year, and the value of any such interest, except that this paragraph does not apply to a real property interest and improvements thereon used as the primary personal residence or for the personal recreational use of the local public officer. If a local public officer, any member of his household or a controlled or dependent business acquired or divested any such interest during the preceding calendar year, he shall also disclose that the transaction was made and the date it occurred. If the controlled or dependent business is in the business of dealing in real property interests or improvements, disclosure need not include individual parcels or transactions as long as the aggregate value of all parcels of such property is reported.
- 6. The names and addresses of all creditors to whom the local public officer or members of his household, in their own names or in the name of any other person, owed a debt of more than one thousand dollars or to whom a controlled business or dependent business owed a debt of more than ten thousand dollars which was also more than thirty percent of the total business indebtedness at any time during the preceding calendar year, listing each such creditor. This paragraph shall not be construed to require the disclosure of debts owed by the local public officer or any member of his household resulting from the ordinary conduct of a business other than a controlled or dependent business. Nor shall disclosure be required of credit card transactions, retail installment contracts, debts on residences or recreational property exempt from disclosure under paragraph 5 of this subsection. debts on motor vehicles not used for commercial purposes, debts secured by cash values on life insurance or debts owed to relatives. It is sufficient disclosure of a creditor if the name and address or a person to whom payments are made is disclosed. If the local public officer, and any member of his household or a controlled or dependent business incurred or discharged a debt which is reportable under this subsection during the preceding calendar year, the report shall disclose that the transaction was made and the date it occurred.
- 7. The identification and amount of each debt exceeding one thousand dollars owed at any time during the preceding calendar year to the local public officer and member of his household in their own names, or to any other person for the use or benefit of the local public officer or any member of his household. The disclosure shall include the identification and amount of each debt exceeding ten thousand dollars to a controlled business or dependent business which was also more than thirty percent of the total indebtedness to the business at any time during the preceding calendar year. This paragraph shall not be construed to require the

disclosure of debts from the ordinary conduct of a business other than a controlled or dependent business. If the local public officer, any member of his household or a controlled or dependent business incurred or discharged a debt which is reportable under this subsection during the preceding year, the report shall disclose that the transaction was made and the date it occurred.

- 8. The name of each source of any gift, or accumulated gifts from a single source, of more than five hundred dollars received by the local public officer and members of his household in their own names during the preceding calendar year, or by any other person for the use or benefit of the local public officer or any member of his household except gifts received by will or by virtue of intestate succession, or received by way of distribution from any intervivos or testamentary trust established by a spouse or by an ancestor, of gifts received from any other member of the household or relatives to the second degree of consanguinity. TRAVEL-RELATED EXPENSES AND POLITICAL CAMPAIGN CONTRIBUTIONS SHALL NOT BE CONSTRUED AS GIFTS IF OTHERWISE PUBLICLY REPORTED AS REQUIRED BY LAW.
- 9. A list of all business licenses issued, by the Town of Thatcher, or by any other governmental agency which requires for its issuance the consideration of the application for such license by the Town of Thatcher Council of the Town of Thatcher, held by or in which the local public officer or any member of his household had an interest at any time during the preceding calendar year, including the name in which the license was issued, the type of business and its location.
- 10. A list of all bonds, together with their value, issued by the Town of Thatcher, any industrial development authority of the Town of Thatcher or any nonprofit corporation organized or authorized by the Town of Thatcher held at any time during the preceding calendar year by the local public officer or any member of his household, which bonds issued by a single entity had a value in excess of one thousand dollars. If the local public officer or any member of his household acquired or divested any bonds during the preceding calendar year which are reportable under this paragraph, the fact that the transaction occurred and the date shall also be shown.
- 11. THE NAME OF EACH MEETING, CONFERENCE OR OTHER EVENT WHERE THE LOCAL PUBLIC OFFICER IS PARTICIPATING IN THE PUBLIC OFFICER'S OFFICIAL CAPACITY IF TRAVEL-RELATED EXPENSES OF ONE THOUSAND DOLLARS OR MORE WERE INCURRED ON BEHALF OF THE LOCAL PUBLIC OFFICER AND THE TRAVEL-RELATED EXPENSES ARE NOT PAID BY THE LOCAL PUBLIC OFFICER.
- B. If an amount or value is required to be reported pursuant to this section, it is sufficient to report whether the amount or value of the equity interest falls within:
  - 1. Category 1, one thousand dollars to twenty-five thousand dollars.
  - 2. Category 2, more than twenty-five thousand dollars to one hundred thousand dollars.
  - 3. Category 3, more than one hundred thousand dollars.

- C. This section does not require the disclosure of any information that is privileged by law.
- The statement required to be filed pursuant to subsection A shall be filed by all persons D. who qualified as local public officers at any time during the preceding calendar year on or before January 31 of each year, with the exceptions that a local public officer appointed to fill a vacancy shall, within sixty days following his taking of such office, file a financial disclosure statement covering as his annual period the twelve month period ending with the last full month prior to the date of his taking office, AND A LOCAL PUBLIC OFFICER WHOSE FINAL TERM EXPIRES LESS THAN THIRTY-ONE DAYS INTO THE IMMEDIATELY FOLLOWING CALENDAR YEAR MAY FILE THE LOCAL PUBLIC OFFICER'S FINAL FINANCIAL DISCLOSURE AT THE SAME TIME AS THE DISCLOSURE FOR THE LAST IMMEDIATELY PRECEDING YEAR.
- The Town of Thatcher Clerk shall prepare written guidelines, forms and samples for completing the financial disclosure statement required by this section. A copy of the guidelines, forms and samples shall be distributed to each local public officer and shall be made available to each candidate required to file a financial disclosure statement pursuant to Section 3 of this resolution.
- ANY STATEMENTS THAT ARE REQUIRED TO BE FILED BY A LOCAL PUBLIC OFFICER PURSUANT TO THIS ORDINANCE/RESOLUTION ADOPTED PURSUANT TO A.R.S. § 38-545 MAY BE FILED IN AN ELECTRONIC FORMAT AS PRESCRIBED BY THE SECRETARY OF STATE.

Section 3. DUTY TO FILE FINANCIAL DISCLOSURE STATEMENT BY CANDIDATE FOR LOCAL PUBLIC OFFICE. A candidate for local public office as specified in Section 1, paragraph 6, shall file a financial disclosure statement covering the preceding twelve month period and containing the information described in Section 2 on a form prescribed by the Town

of Thatcher Clerk at the time of filing nomination papers.
<b>Section 4.</b> This resolution shall become effective on the 31 <sup>st</sup> day of December, 2016.
