A. Contract Extension for Sewer Pipeline Cleaning & Inspection Services: BCAC Underground, \$46,975.34

Mr. Brown explained that this is the 3rd year for the Town to do the sewer cleaning and CCTV. Last year this company was lower than the competition and therefore the contract allowed for a one-year extension. The Town has received the same cost per foot price as last year from BCAC. The area has been outlined for an estimated area and the Town will be billed for actuals.

Councilmember Rapier made a motion to extend the contract and it was seconded by Councilmember Howard. Motion carries unanimously.

B. Infrastructure Acceptance of Sunset Circle Subdivision

Mr. Brown explained that this is the street, sewer, and storm water improvements that have gone in for the Wayne Layton subdivision also known as the Sunset Circle Subdivision. It is completed, Town Engineer Tom Palmer has inspected it and stated it looks ready to go. The Town is ready to accept maintenance and will start maintaining the sewer and the streets. The subdivision is getting ready to sell lots. The retention basin will be landscaped with desert landscaping.

Vice Mayor Smith made a motion to accept the Infrastructure of Sunset Circle Subdivision and it was seconded by Councilmember Rapier. Motion carries unanimously.

Public Works Projects

- Recreation Complex Restrooms are under construction by Brandon Lunt off site. Brandon is shooting for late February, early March to finish.
- 1st Avenue Drainage The extra pipe that was ordered is in and we are now placing the pipe back in.
- High School Avenue Project, etc.
 All the power on the west side is underground and active. All the overhead power on that side is down and 75% of the phone and internet down. We will now be installing the underground storm drain on that side which is 2,000 feet. We started it today.
- Welcome to Thatcher Signs
 Taking longer than anticipated. Steel was used to cover the electric on the back side of the signs.
- Playground Layout at the Recreation Complex
 Committee was created to weigh the pros and cons. The committee decided to leave the majority of the playground and is adding a zipline.
- Red Lamp RFP
 The RFP's are due Thursday and as of today one proposal has been submitted. Mr. Brown would like to schedule an executive session meeting to get feedback.
 Councilmembers and Mr. Brown decided on Monday, February 7th for the executive session meeting.

- Highway Beautification Grant
 - The Town only received 3 applications this year, Tom's Service Center, one residential, and Gila Outdoor. The total amongst the 3 is about \$28,000. Last year we awarded Kainoa's \$10,000 for their parking lot and it was not used. Mr. Brown asked the council about funding all 3 applications this year. The council agreed.
- SPPA Natural Gas Hedging
 Dennis Daleny & KR Saline is recommending that we hedge the price of our natural gas
 and create a set price ahead of time. They are working on a resolution draft to present
 to the different entrities.
- Monthly Financial Summary
- Police Department
 Chief Woods stated that the K9 car has been built. Officer Maner will be attending the K9 school for 2 months starting February 8th. Dave Perkins has been hired to build a kennel for the dog that will reside at Officer Maner's home.
- Fire Department Chief Payne stated that the reelections are tomorrow. There is also an upcoming house burn taking place on Church and 3rd Avenue.

FRANCHISE AGREEMENT

between

TOWN OF THATCHER AND SOUTHWEST GAS CORPORATION

WHEREAS, a natural gas utility and its functions are a highly desirable service for the Town of Thatcher, and

WHEREAS, the Town of Thatcher believes that Southwest Gas Corporation, a California corporation ("Southwest Gas"), a natural gas utility with operations in Graham County, Arizona, can supply those services, and

WHEREAS, said services would be highly beneficial to all of the inhabitants thereof:

NOW, THEREFORE, BE IT RESOLVED, by the Town council of the Town of Thatcher, Graham County, Arizona, that subject to the terms, conditions, and limitations hereinafter contained, there is hereby granted to Southwest Gas, a franchise, rights-of-way, easements, and necessary privileges to construct, maintain, operate in, over, upon, along, under and across all of the public and city roads, highways, streets, avenues, boulevards, alleys, and public places and grounds within the confine of the Town of Thatcher, all necessary pipes, services, storage, transmission and distribution mains, meters, connections, fixtures and other property, facilities and equipment for its gas system operations and for distributing, transmitting and selling to the businesses, residences and the inhabitants of the Town of Thatcher, natural gas, renewable natural gas, hydrogen and/or artificial gas, including gas manufactured by any method whatsoever, and/or gas containing a mixture of natural gas, renewable natural gas, hydrogen and/or such artificial gas (herein all types of gas will be collectively referred to as "gas") for heating, power, lights and all other purposes within the Town of Thatcher.

1. All rights hereby granted are subject to other rights, privileges, franchises, easements and rights-of-ways, heretofore

granted by the Town Council of the Town of Thatcher, Graham County, Arizona, and now in force.

- 2. All rights hereby granted shall be exercised so as not to interfere or conflict with any other easement either public or private of any nature, which may have been acquired in and to the proper uses of highways, roads or streets, or any portion thereof covered by this franchise prior to the effective date hereof.
- 3. All rights hereby granted shall be exercised so as not to unreasonably interfere or conflict with or endanger in any way the proper use by the public of said highways, roads, streets or any portion thereof covered by this franchise.
- 4. If in the construction, maintenance or operation of its gas system, Southwest Gas damages or disturbs the surface or subsurface of any public street, road or highway, Southwest Gas, at its expense, shall be responsible for restoring the surface or subsurface of the public street, road or highway to a reasonably similar condition as existed at the time of the damage or disturbance and consistent with required construction standards in effect at that time. In the use of the surface of the highways, paths, streets, roads, avenues, alleys or public grounds covered by this franchise, Southwest Gas shall maintain the same when so used in such condition as to interfere as little as reasonably possible with the use thereof by the public.
- 5. All pipes or mains for gas laid by Southwest Gas, its successors or assigns, under this franchise, shall be laid at sufficient depth underground as not to directly and physically conflict with facilities to be installed as part of any Town of Thatcher public improvement project for the highways, roads, street or alleys, along, under or across which the said pipes or mains shall be laid, and the same may be lowered or re-laid as may be hereafter required for any Town of Thatcher public improvement project, where it is necessary for the same to be re-laid to prevent a direct and physical conflict with facilities to be installed as part of such improvement project.

- 6. Southwest Gas shall save and hold the Town of Thatcher harmless from loss, cost, damage or expense the Town of Thatcher may suffer or incur arising out of Southwest Gas' failure to comply with the terms of this franchise or as a result of any action by Southwest Gas or its agents in the construction, operation or maintenance of its gas utility system under this franchise.
- 7. That Southwest Gas shall continue to furnish gas service to the inhabitants of the Town of Thatcher upon the granting of this franchise.
- 8. This franchise, rights and privileges shall continue for a term of twenty-five (25) years from the date of the granting of the same.
- 9. The terms and conditions of this franchise shall inure to the benefit of and be binding upon all of the successors and assigns of Southwest Gas.
- 10. There shall be imposed upon Southwest Gas. a franchise fee of 2% of the gross revenues from the sale and/or delivery by Southwest Gas of all gas to Southwest Gas' customers within the corporate limits of the Town of Thatcher ("franchise fee"), which shall be in lieu of any other franchise, occupation, privilege, or other fees or taxes and payable on a quarterly basis. The franchise fee shall be added to any established gas rate as approved by the Arizona Corporation Commission and billed to Southwest Gas' customers within the Town of Thatcher.

ORDINANCE NO. 193-2022

AN ORDINANCE OF THE COMMON COUNCIL OF THE TOWN OF THATCHER, ARIZONA, GRANTING TO SOUTHWEST GAS CORPORATION, ITS SUCCESSORS AND PERMITTED ASSIGNS, A PUBLIC UTILITY FRANCHISE; PROVIDING FOR AN EFFECTIVE DATE; PROVIDING FOR THE REPEAL OF CONFLICTING ORDINANCES; AND PROVIDING FOR SEVERABILITY

WHEREAS, Southwest Gas Corporation, a California corporation, has submitted a proposed franchise to be granted to Southwest Gas Corporation, its successors and permitted assigns, by the Town of Thatcher for the purpose of constructing, maintaining, and operating its gas system and gas system facilities upon, over, across, and under the present and future public rights-of-way of the Town of Thatcher for the purpose of supplying natural gas and/or artificial gas, including gas manufactured by any method whatsoever, and/or gas containing a mixture of natural gas and such artificial gas to the Town, its successors, inhabitants, and all individual and entities, either within or beyond the limits thereof, for all purposes; and

WHEREAS, the Constitution and laws of the State of Arizona provide for and require the submission of the proposed franchise to the qualified electors of the Town of Thatcher for their approval or disapproval; and

WHEREAS, the Town Council finds that it is appropriate, proper, and in the best interests of the Town to grant Southwest Gas Corporation a franchise as set forth herein.

NOW, THEREFORE, BE IT ORDAINED by the Common Council of the Town of Thatcher, Arizona, as follows:

Section I. Grant of Franchise.

That, subject to approval by the qualified electors of the Town of Thatcher, there is hereby granted to Southwest Gas Corporation, a California corporation, its successors and permitted assigns, the right and privilege to construct, maintain, and operate its gas system and gas system facilities upon, over, across, and under the present and future public rights-of-way of the Town of Thatcher for the purpose of supplying natural gas and/or artificial gas, including gas manufactured by any method whatsoever, and/or gas containing a mixture of natural gas and such artificial gas to the Town, its successors, the inhabitants thereof, and all individuals and entities, either within or beyond the limits thereof, for all purposes as described and prescribed by the terms and conditions of that certain document titled "Franchise Agreement Between Southwest Gas Corporation and the Town of Thatcher, Arizona" attached hereto, subject to revisions approved by the Town Attorney prior to publication in the Election Pamphlet if such revisions to not substantially change the material terms of the Franchise Agreement.

Section II. Effective Date.

The provisions of this Ordinance shall become effective June 1, 2022, if approved by the qualified electors of the Town of Thatcher at an election to be held on May 17, 2022.

Section III. Providing for Repeal of Conflicting Ordinances.

All ordinances and parts of ordinances in conflict with the provisions of this Ordinance or any part of the Code adopted herein by reference are hereby repealed.

Section IV. Providing for Severability.

If any section, subsection, sentence, clause, phrase or portion of this Ordinance or any part of the Code adopted herein by reference, is for any reason held to be invalid or unconstitutional by the decision of any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions thereof.

ARGUMENT "FOR" APPROVAL OF THE FRANCHISE AGREEMENT:

Please join us in voting YES on the ballot questions approving a franchise agreement with Southwest Gas Corporation. Passage of this ballot question will provide final approval to a new franchise agreement that will set the terms of the working relationship between the Town of Thatcher and Southwest Gas for the next 25 years.

Southwest Gas recently began serving our community with natural gas in early 2022. The Thatcher Town Council has approved and referred a new franchise to the citizens of Thatcher for consideration. If approved, voters will authorize Southwest Gas to use our public rights-of-way to continue to provide our community with safe, affordable and reliable energy to power our economy and to meet our at home comfort needs. This agreement is the same as the prior agreement the Town had with Graham County Utilities.

A vote for approval of the franchise is a vote to renew the Town's important oversight function of Southwest Gas.
